Technical Requirements

Hardware requirements

CPU: Pentium or higher.

Internet connection requirements

Internet Service Provider for accessing the web-tool via browser. We recommend a high speed connection (ADSL).

Browser requirements

- In order to access the web-tool Internet Explorer 10.x, Internet Explorer 11.x or Firefox version 5 2.0 is needed. You can check your Internet Explorer version by selecting "?"/"Information on Internet Explorer" or your Firefox version by selecting "Help"/"Information on Firefox".
- SSL (Secure Socket Layer, protocol for secure transaction) suitability is required. You can check whether you satisfy this requirement by selecting "Tools" -> "Options" -> "Advanced" from Internet Explorer menu. The options "Use SSL 2.0" and "Use SSL 3.0" should be flagged.
- Cookies enabling is required: you can find instructions on this topic in the "Help me" -> "Cookies" section on the Eni e-Procurement portal.
- Saving encrypted pages to disk must be allowed: see instructions on support.microsoft.com website.
- Resolution: the optimal resolution for the web site is 1024x768 pixel.



Technical Requirements

Software requirements

- It's recommended to use one of the following systems:
 - Windows 7 32 bit or 64 bit
 - Windows 10
- An active e-mail address is required so that you can receive e-mail notifications when a document is delivered.
- Microsoft Office to display the auction's documentation. Free copies of the Microsoft Office viewers can be downloaded from www.microsoft.com.
- Acrobat Reader is needed for opening .pdf files containing documents notifications. Acrobat Reader is available free of charge at the following address: http://www.adobe.it/products/acrobat/readstep.html. Version 8.0 or higher is recommended.
- In order to use all the Service functionalities you need to install the JRE Java Runtime Environment applet: Minimum release: 1.5.xx. The file can be downloaded on the SUN web site at the following address: www.java.com/it.


In order to access the web-tool and to submit a bid, open the web browser (Internet Explorer or Firefox) and go to the web site https://eprocurement.eni.it/

Electronic Bidding Rules and Regulations (

Electronic Bidding Rules and Regulations

- a. The rules hereinafter expressed ("Electronic Bidding Rules and Regulations") govern the electronic part of the relevant Auction (hereinafter "Bidding") following which the Bidders are invited to submit their bids.
- b. The Bidders take part to the Bidding connecting up via Internet to the reserved area of the website (hereinafter "the Portal"). They shall send their bids electronically and in accordance with the present document.

General Rules

- a. The Bidder acceptance of the terms and condition of this Auction Procedure including the Electronic Bidding Rules and Regulations, given by the signature of the Application Form, allows the Bidder to participate in the Bidding.
- b. The acceptance of the Electronic Bidding Rules and Regulations has to be even given on-line at any access to the Bidding. The non-acceptance will cause the impossibility to gain access

Access Procedures

- a. The minimum hardware, software and Internet requirements needed for the participation in the Bidding are published on the Portal. The purchase, installation, configuration and the hardware and software maintenance are in sole charge and under the responsibility of the Bidder.
- b. The participation in the Bidding requires the registration on the Portal and the identification of the Bidder by a user code (userId) and an operating code (password) assigned by Eni and sent to the Bidder by the Acceptance Notice.
- c. The Bidder gives to Eni the authorization to carry out in succession the recording of contacts and transactions by telephone or computerized systems occurred during the participation in the Bidding.
- d. Eni will forward any and all information and notices to the Bidders by the electronic mail address notified in the Application Form.

- e. Further instructions for the access to and the participation in the Bidding are provided through the corresponding Bidder Manual which will be provided to all Interested participants. If either the information required is not given or it is erroneously given or the operating procedures are not observed, it will not be possible for Bidder to participate in the Bidding.
- f. The Bidder can contact the Service Operations Support (SOS) for technical assistance even while the Bidding is running by telephone, along with the telephone number of the SOS. There will be a dedicated phone number active for the events of Test Auction and Bidding. This number will be indicated in the Acceptance Notice.

Rules For the Use of the Password


- a. Each Bidder is obliged to change the password at the first access to the Portal and has the right to modify it whenever he wants.
- b. Each Bidder shall keep the password secret. The Bidder is responsible for the safe keeping and the correct use of the userId and the password. The Bidder is also responsible for their improper use, however occurred, even in case of loss or theft.
- c. The direct, indirect, total, partial, voluntary or involuntary divulgation of the password to third parties is wholly under the responsibility of the Bidder, who will be liable for any damage suffered by Eni further to the divulgation of the password. Any and all divulgations will constitute, to all intents and purposes, an authorization for third parties to have access to the Portal.
- d. In case of loss or theft of the password the Bidder has to ask for the immediate blocking of userId by contacting the SOS. The Bidder will be responsible for any use of userId and password until notification of the blocking.

Bidding Procedure


- a. The Bidders shall send their electronic bids on the basis of the relevant Auction Procedure and in accordance with the corresponding Bidder Manual.
- b. Each Bidder guarantees that the bids will be sent by a person authorized to represent the Bidder.
- c. The name and number of Bidders are not visible to the other competitors.
- d. Eni guarantees the confidentiality of the technical or commercial information received by the Bidders.
- e. The Bidding expires automatically by means of the Portal for all Bidders.
- f. The award of the Bidding shall conform to the provisions of the Auction Procedure.
- g. The Bidding may be suspended or delayed upon discretion of Eni due to good reason in particular due to difficulties in the connection with the Portal caused by malfunctions in the Portal or relevant to the Eni IT system.
- h. The Bidder cannot enter his bid into the Portal after each Round expires.
- i. It is possible to participate in the Bidding only if the provisions of the Auction Procedure are complied with.


- Auction type indicates the name of the auction with the specific round number

- Bid submission deadline indicates the date and time by which Bidder have to submit its Bid. The system will not accept Bids after this deadline!






View Bid Invitation

- 5 The Number of Lot(s) for "Product"






Create Bid



- In the Attributes folder insert into "Reply" field, according to the Auction Procedure for the Available Transportation Capacity:
- the *Number of Lot(s)* for the specific "Product"
- 3 the **Bid Fee €/MWh/h/Month** for Subletting Product. The Price shall be with two decimal places and comma is used as separator of decimal places (e.g. XXX,xx).



Create Bid



- Please Check before submitting if your bid is lower or equal to the maximum number of lots
 - In case the selected lot-number exceeds the maximum number of lots a warning message appears and the bid shall not be accepted.
 - The message indicates the maximum number of lots a Bidder is allowed to bid.



Submit Bid

- In order to send the Bid click "Submit"
- In order confirm the bid submission click "Ok"





Once a bid has been submitted it cannot be edited anymore!




In order to save your bid for later proceeding click "Hold" (NOT RECOMMENDED)



Held or returned Bids

This is an exceptional procedure to be used only in the following cases:

- □ Bid unintentionally held
- □ Bid returned the Seller due to Bidder's failures.

- In order to display the data of a Bid click the Bid number or
- Select in order to display the data of a previous Bid
- In order to modify a held Bid (saved but not sent) or a returned Bid select 🥬
