The amendment to the By-laws takes place following the execution of the cancellation of 118,782,928 treasury shares purchased, for the purpose of remunerating Shareholders, during the buyback program authorized by the Shareholders' Meeting of 14 May 2025 and terminated on 18 February 2026, as disclosed to the market on 25 February 2026.
