GUIDELINES FOR COMPLETING THE FORM

The Candidate is kindly requested to read the following instructions carefully before completing this Application Form.

The purpose of this document is to provide the information required for the evaluation of the candidature. The information supplied shall be accurate, complete and consistent with the supporting documentation submitted in accordance with the Official Announcement.

Structure of the Application Form

The Application Form is organized into the following sections:

Section 1 – Candidate Information

This section is intended to collect information on the Main Author (in the case of a single candidature) or on the two (2) Main Authors (in the case of a double candidature) responsible for the research results submitted.

The Main Author(s) must be corresponding author(s) of at least one of the scientific publications listed in Section 3 and the reference letters listed in Section 4 shall refer to both. The Main Author(s) must be authors of the patents or patent applications listed in Section 5.

Additional collaborators who contributed to the research results may be indicated as Secondary Authors. However, Secondary Authors shall neither be eligible for the Prize nor be included in the Prize-Giving Ceremony and related media activities.

Section 2 – Submission of the Research and selection of the Prize Section

This section indicates the title of the submitted research and identifies the Prize Section (one only) for which the Candidate intends to apply, in accordance with the evaluation criteria set out in Article 2 of the Official Announcement of respectively the *Advanced Environmental Solutions*, *Energy Transition* or *Energy Frontiers* Prize.

Once the Prize Section is selected, the relevant sub-topic (maximum one) under which the candidature is submitted shall be indicated.

Please note that Section 6 shall be compiled only for the selected Prize Section.

Finally, the Candidate is requested to indicate whether the research object of the candidature represents a first submission or a resubmission. In the latter case, Candidate must highlight the new developments of the research since the last submission. Resubmissions requirements can be found in Article 4 of the Official Announcement.

Section 3 – Selected Publications

With reference to Article 4 of the Official Announcement, this section is intended to collect information on the publications most relevant to the results (achieved within the last ten (10) years) of the submitted research (minimum one (1) – maximum five (5) peer-reviewed publications referred to research results achieved within the last ten (10) years, excluding reviews and patents).

The Candidate is also kindly reminded that copy of the listed publications (in .pdf files) must be submitted separately in the same numerical order in which they are listed in the Application Form, by uploading to the private area or sent by e-mail to the contact person.

Section 4 – Reference Letters

With reference to Article 4 of the Official Announcement, this section is intended to collect the reference letters (at least three (3) – maximum five (5), of which no more than two (2) may be sent from the same country).

The letters shall be compulsorily written in English, refer explicitly to the Eni Award, be dated and be signed by authoritative members of the academic, scientific or business community. Only letters that certify the scientific value, innovation level and potential applicability of the submitted research proposal will be considered. At least one paragraph of such letters shall be devoted to the description of the results achieved by the Main Author(s) over the past ten (10) years, in order to describe their career with focus on this specific period of time.

The Candidate is also kindly reminded that copy of the listed letters (in .pdf files) must be submitted, by uploading to the private area or sent by e-mail to the contact person.

Section 5 – Selected Patents and Patent Applications (Optional)

With reference to Article 4 of the Official Announcement, this section is intended to collect, where applicable, information on selected patents and patent applications (maximum three (3)) related to the submitted research.

Copies of the listed patents and patent applications (in .pdf files) may be submitted by the Candidate by e-mail to the contact person.

Section 6 – Description of the Research Results
