



Eni's Board of Directors

Approval of the third tranche of the provision in place of 2025 dividend: € 0.26 per share

Rome, 25 February 2026 – Eni's Board of Directors, chaired by Giuseppe Zafarana, today resolved to distribute to Shareholders the third of the four tranches of the provision in place of the 2025 dividend¹ from Eni S.p.A. available reserves of € 0.26 (compared to a total annual provision, in place of the dividend, equal to € 1.05) per share outstanding at the ex-dividend date as of 23 March 2026², payable on 25 March 2026³, as resolved by the Shareholders' Meeting of 14 May 2025.

Holders of ADRs, outstanding at the record date of 24 March 2026, will receive € 0.52 per ADR, payable on 8 April 2026⁴, with each ADR listed on the New York Stock Exchange representing two Eni shares.
