5. that the participation in the Auction does not violate any provisions of the Applicant's constitutional documents and will be carried out in compliance with all applicable laws and regulations;
6. that the Applicant will adhere to the confidentiality requirements according to Article 19 of the Auction Procedure;
7. that it will not collude and has not colluded with other applicants in the Auction (including but not limited to for the coordination of bidding behaviour and strategies);

8. that the Applicant acknowledges and accepts that an Application Form, or a Bid Bond or a Declaration not conform to the requirements of the Auction Procedure, or a false Declaration hereunder will cause the exclusion of the Applicant from the participation to the Auction.
9. that the Applicant acknowledges and accepts that the Auction Procedure and documentation is governed by Italian law and that all disputes shall be referred to the exclusive jurisdiction of the Court of Milan.
